# INTERNATIONAL RELATIONS (INR)

## INR 2002 - Intro International Relations (3 Credits)

Introduction to major theoretical perspectives, institutional structures and issues of global politics.

Attribute(s): GESO - Gen. Ed -Social Science, Gen. Ed -Social Science, SCIQ - Scientific Inquiry, Scientific Inquiry

#### INR 3003 - Theories of Int'l Relations (3 Credits)

Examination of major theoretical traditions of international relations and interpretations of current international realities form the prospectus of these traditions.

Prerequisite(s): ENC 1102

# INR 3955 - Overseas Study (1-3 Credits)

This course is a program of individual or group research in a foreign country.

## INR 4061 - International Armed Conflicts (3 Credits)

This course examines the causes, characteristics, and outcomes of contemporary international armed conflicts, as well as the consequences of these for international relations.

## INR 4075 - International Human Rights (3 Credits)

Examines international human rights issues and their impact on politics. Major topics include: international human rights organizations and legal conventions; ethical and political ambiguities in international human rights; conflicts between human rights, local culture, and economic globalization.

# INR 4303 - U.S. Foreign Policy (3 Credits)

Examination of U.S. foreign policy, including economic policy, counterterrorism, national defense, U.S. diplomacy toward key countries and regions of the world, and the governmental machinery through which foreign policy is formulated and implemented.

INR 4333 - International Security (3 Credits)

Survey of key concepts and issues in the field of International Security.

Prerequisite(s): ENC 1102

# INR 4502 - International Organizations (3 Credits)

Examination of the development and operation of international organizations.

Prerequisite(s): ENC 1102

# INR 4703 - International Political Econ (3 Credits)

Examines the major structures and key actors within the contemporary global economy. Topics include international monetary order, regional and multilateral trade regimes, international financial flows, the roles of multinational corporations, economic development strategies, and world cities. These topics will be investigated from a variety of theoretical perspectives (e.g., liberal, mercantilist, structuralist).

## INR 4910 - Directed Independent Study (1-3 Credits)

Provides an opportunity for students to engage in research of their choice in special areas of interest. The research may be carried out on an individual or group basis but must be under the supervision of the instructor. This course is intended to help students acquire skills in applying research principles and obtaining practice in rigorous data collection and reporting.

### INR 4930 - Special Topics Intl Relations (3 Credits)

Examination of a selected topic within international relations. Topics may

vary depending on instructor. Prerequisite: ENC 1102
